At the time of their first UD, there were fewer than 10 Norwich Terriers with a UD in the U.S.A. In Rally, they have obtained 3 RNs, 3 RAs, 2 REs, and 1 RAE. Their Norwich was the first Norwich in the country to earn the RAE title. In Freestyle, one of their Norwich earned a first place in CFF Level 2 competition and came in first in a group competition.
